2020 PROJECTS

The team of Environmental Assessment Practitioners (EAPs) were fortunate enough to work on a vast array of projects this year. Some of the projects we worked on are highlighted below:

Roads:

We have extensive experience in undertaking applications for multiple road projects across KwaZulu-Natal and most recently Eastern Cape. The assessments included BARs, WULAs, EMPr's and rehabilitation plans.

Structures:


